ORDINANCE #145 AMENDED PARADE

BE IT KNOWN THAT AT A REGULAR MEETING OF THE MAYOR AND THE BOARD OF ALDERMEN OF THE TOWN OF PEARL RIVER, ST. TAMMANY PARISH, LA. HELD IN THE TOWN HALL ON TUESDAY, FEBRUARY 8, 2000 AT 7:00P.M.

AN ORDINANCE REGULATING AND CONTROLLING ALL PARADING, MARCHING PICKETING OR DEMONSTRATING IN OR ON PEARL RIVER'S STREETS AND SIDEWALKS OR CLUTTERING UP THE STREETS OR SIDEWALKS WITH DEBRIS OR ARTICLES OF ANY OTHER NATURE SUCH AS NAILS, TACKS, BOTTLES, ROCKS, BRICKS, PAPER, TRASH, ETC.

"BE IT ORDAINED THAT IT SHALL BE UNLAWFUL FOR ANY PERSON OR PERSONS WITHOUT THE WRITTEN PERMISSION OF THE TOWN OF PEARL RIVER, LOUISIANA, TO ENCOURAGE, ORGANIZE, PROMOTE, CONDUCT OR PARTICIPATE IN ANY PARADE OR MARCHING ON THE SIDEWALKS, STREETS AND PUBLIC WAYS OF THE SAID TOWN, OR TO WALK, RIDE OR STAND IN ORGANIZED GROUPS ON SAID SIDEWALKS OR STREETS WHILE CARRYING BANNERS, PLACE CARDS, SIGNS OR THE LIKE, OR TO SIT, KNEEL OR RECLINE ON THE SIDEWALKS OR STREETS OF SAID TOWN OR TO ENGAGE IN PUBLIC SPEAKING, GROUP SHOUTING, GROUP SINGING OR ANY OTHER SIMILAR DISTRACTING ACTIVITY ON ANY OF THE SIDEWALKS, STREETS OR PUBLIC WAYS OF SAID TOWN, OR TO ASSEMBLE IN GROUPS ON ANY SIDEWALK OR STREET IN SUCH MANNER OR NUMBERS AS TO BLOCK OR INTERFERE WITH THE CUSTOMARY AND NORMAL USE THEREOF BY THE PUBLIC UNLESS THE PERSONS SO ASSEMBLED IN SUCH GROUPS ARE ENGAGED IN WATCHING A MARCH OR PARADE AUTHORIZED BY THE PROVISION HEREOF; PROVIDED, HOWEVER, THAT NO WRITTEN PERMISSION OF THE TOWN OF PEARL RIVER SHALL BE REQUIRED FOR A BONA FIDE FUNERAL PROCESSION IN ROUTE TO A CEMETERY OR FOR ANY PARADE OR MARCH BY ANY UNIT OF THE LOUISIANA NATIONAL GUARD OR THE UNITED STATES ARMY, NAVY, AIR FORCE OR MARINE CORPS."

"IN THE EVENT OF ANY PICKETING OF ANY PARTICULAR PLACE OF BUSINESS IN SAID TOWN, ALL SUCH PICKETS SHALL WALK SINGLY, WITH NO PAIRS OR MORE ABREAST OF EACH OTHER, AND SHALL FOLLOW OTHER PICKETS AT A DISTANCE OF NO CLOSER THAN SIX FEET TO THE END THAT NO SIDEWALKS OR PUBLIC WAYS SHALL BE BLOCKED OR IMPEDED."

BE IT FURTHER ORDAINED THAT THIS ORDINANCE #145 IS HEREBY AMENDED BY ADDING THE TWO FOLLOWING SECTIONS:

SECTION 1: IT SHALL BE UNLAWFUL FOR ANY SPECTATOR OR PARTICIPANT TO THROW, SPRAY OR PROPEL, OR CAUSE TO BE THROWN, SPRAYED OR PROPELLED ANY OBJECT OR SUBSTANCE AT OR TOWARD ANY SPECTATOR OR PARTICIPANT OF A PARADE WHILE SUCH PARADE IS FORMING, BEING HELD OR DISBANDING;

IT SHALL BE UNLAWFUL FOR ANY STREET VENDOR TO SELL ANY OBJECT OR SUBSTANCE DURING THE PERIOD FOR WHICH A TEMPORARY VENDOR'S PERMIT

IS ISSUED PURSUANT TO THE CODE OF ORDINANCES OF THE TOWN OF PEARL RIVER.

ANY OBJECT OR SUBSTANCE MEANS SILLY STRING OR ITS EQUIVALENT, CRACKER BALLS, FIRECRACKERS, OR ANY PYROTECHNIC OR EXPLOSIVE DEVICE.

SECTION 2: THE PRESENCE OF ANIMALS AND REPTILES OTHER THAN THOSE ON FENCED PRIVATE REAL PROPERTY, OR THOSE WHICH ARE ACTUALLY PARTICIPATING IN A PARADE OR OTHER PERMITTED PUBLIC EVENT IS PROHIBITED WITHIN ONE HUNDRED AND FIFTY FEET (150') OF THE CENTER LINE OF THE HIGHWAY OF THE PARADE ROUTE OR THE SITE OF THE PUBLIC EVENT.

"EVERY PERSON CONVICTED OF A VIOLATION OF ANY PROVISIONS OF THIS ORDINANCE SHALL BE PUNISHED BY A FINE OF NOT MORE THAN \$200.00 OR BY IMPRISONMENT FOR NOT MORE THAN 30 DAYS OR BY BOTH SUCH FINE AND IMPRISONMENT."

BE IT FURTHER ORDAINED THAT THIS ORDINANCE BE AND IT IS HEREBY DECLARED AN EMERGENCY ORDINANCE AND IS EFFECTIVE IMMEDIATELY.

At the regular scheduled Council Meeting on **January 10, 2012** held at 7:00p.m. the Board of Aldermen agreed to add **SECTION 3** to **ORDINANCE#145** (**PARADE**) to read as following:

SECTION 3: It shall be unlawful for any person to operate or permit the operation of any place where intoxicating liquor is served **for consumption on such premises** within the corporate limits of the Town from the hours of 2:00 a.m. until 6:00 a.m. On Sunday the Day of the Parade the establishments will be closed at 10p.m. until 6:00a.m.on Monday with the only exception being New Year's Eve.

The amended ordinance will become effective immediately upon adoption.
