

TOWN OF PEARL RIVER COUNCIL MEETING February 20, 2024, at 7:00 P.M.

CALL TO ORDER:

The Council Meeting was held at the Pearl River Town Hall and called to order by Mayor Lee at 7:00 p.m.

INVOCATION:

The Invocation was given by Alderman Galloway.

PEARL RIVER POLICE DEPARTMENT

The Month of January

Notable Incidents

In the month of January, the Pearl River Police Department completed another successful Madi Gras season. To include assisting with the Pearl River Parade, which had no major incidents. The Pearl River Police Department also assisted surrounding agencies with their parades.

Notable Arrest

On January 11, 2024, Pearl River Police Officers conducted a traffic stop at the Circle K due to an expired registration. During the course of the traffic stop, the Officer located 34 grams of Marijuana, 20 THC Vape pens and Gummies containg THC. The passenger in the vehicle admitted to the Officers that she had just sold Marijuana to a friend for \$60.00. The passenger was charged with Possession with the intent to distribute a Schedule I Controlled Dangerous Substance.

The Pearl River Police Department has been receiving numerous citizen complaints regarding illegal narcotic activity at a trailer in Messer trail park. Based on those complaints, on January 17, officers initiated a narcotics investigation that resulted in officers executing a search warrant at the trailer. Officers located 153 Gabapentin pills, Crystal Methamphetamine, 4 Hydrocodone, and several crushed methadone pills. The Officers also located drug paraphernalia consistent with the packaging and distribution of narcotics. The perpetrator was not on the scene, but an arrest warrant has been issued for his arrest.
