

TOWN OF PEARL RIVER COUNCIL MEETING July 18, 2023 at 7:00 P.M.

CALL TO ORDER:

The Council Meeting was held at the Pearl River Town Hall and called to order by Mayor Lee at 7:00 p.m.

INVOCATION:

The Invocation was given by Alderman Galloway.

PLEDGE OF ALLEGIANCE:

The Pledge of Allegiance was led by Mayor Lee.

ROLL CALL:

Present: Alderman Franatovich, Moray, Galloway and Schultheis, along with Mayor Lee, Attorney Mathison, Attorney Daigle. Absent: Alderman Phillips and Chief Sessions.

SPECIAL GUEST:

Tommy Williams - Candidate for St Tammany Parish Sheriff: Outlined his qualifications for the Sheriff's position.

Alderman Schultheis made a motion to add Leah Long, to the agenda, seconded by Alderman Franatovich; Ms. Long is the Regional and Coalition Director for Senator Kennedys office. Her office can assist with support letters for grants, infrastructure, as well as veteran, social security and passport issues.

APPROVAL OF MINUTES:

Mayor Lee called for the approval of the minutes for the June 20, 2023, Council Meeting. Alderman Galloway, made the motion to accept, seconded by Alderman Schultheis. Mayor Lee called for a roll call vote; Alderman Franatovich, Yea; Alderman Moray, Yea; Alderman Galloway, Yea; Alderman Schultheis, Yea. **All in favor, So moved.**

Ordinance Introductions:

- **B.** Ordinance No. 23-07-18 (B) An ordinance relative to re-subdivision of Pump Slough Property A.G. Crowe.

There will be a public hearing on these ordinances on August 15, 2023 at 7:00 p.m. at Town Hall.

Public Hearings:

A. Ordinance 22-12-20 (B) – An ordinance amending the Fiscal Year 2023 budget. Alderman Galloway made a motion to accept. Seconded by Alderman Moray.

DISCUSSION:

The budget was amended to include the new SRO contract. The line-item adjustments were moving funds from the general fund to capital expenditures for the police dept renovations; increases in the court fines and 4th of July program as well as decreases in building inspector and the water dept. The revenue should begin to increase now that the meters are installed. Mayor Lee called for a roll call vote; Alderman Franatovich, Yea; Alderman Moray, Yea; Alderman Galloway, Yea; Alderman Schultheis, Yea. All in favor, So moved.

B. Ordinance 23-06-20 – An ordinance relative to Zoning District Regulations. Alderman Schultheis made a motion to table; seconded by Alderman Galloway; Mayor Lee called for a roll call vote; Alderman Franatovich, Yea; Alderman Moray, Yea; Alderman Galloway, Yea; Alderman Schultheis, Yea. **All in favor, So moved.**

Notable Incidents

On June 29, while conducting a traffic stop investigation on the I-59 interstate, a Pearl River Police Officer was almost truck by a on coming truck. The truck did strike the Officers unit and then fled towards Mississippi. The Hit and Run was handled by the State Police. Based on Pearl River Detectives, the Department was able to identify the company of the truck and the driver. All the information was turned over to the State Police, who issued the driver a summons for Hit and Run.

Notable Arrests

On June 10, while conducting a traffic stop, Pearl River Officer observed a handgun in the vehicles glove compartment. The Officer checked the weapon through NCIC and discovered that the weapon had been reported stolen from Mississippi. The driver was placed under arrest for possession of a stolen firearm.

On June 17, Pearl River Officer was running Radar on LA 41. The Officer clocked a vehicle traveling 61 MPH in a 45 MPH zone. During the course of the investigation, the Officer discovered that the driver was in possession of 18 grams of marijuana and 19 Taurus. The driver was placed under arrest for possession of a firearm while in possession of a controlled dangerous substance.

On June 20, Pearl River Officer was running Rada on the I-59 interstate. The Officer clocked a vehicle traveling at 90 MPH in a 70 MPH zone. During the course of the investigation, the Officer discovered the driver to be in possession of a MP 22 Assault Rife a 9 mm Taurus and 15 grams of

marijuana. The driver was placed under arrest for possession of a firearm while in possession of a controlled dangerous substance.
